Subject:	Calling Letter – Alternate Threat Scenarios 2022 Seminar (ATS22), 20-22 September 2022.

- 1. The C-IED Centre of Excellence will organise the **Alternate Threat Scenarios 2022 Seminar (ATS22)** in Madrid (SPAIN) from 20 to 22 September 2022.
- 2. The **generic objective** of the **ATS22** is to join NATO, 7NNN & EU experts (Military, Law Enforcement, Security Agencies, Emergency Services, Civilian Authorities...) related to analysis, anticipation, prevention, response, preparation & lessons learned regarding threat scenarios and associated planning, exercises and/or assessment to them, all together.
- 3. The **aim** of **ATS22** event is to provide a favourable space to present alternate (so those emerging, unprecedented, never directly faced, unexpected or modified from current ones) models for threat scenarios as developed by non-state actors, just in benefit of critical thinking analysis.
- 4. The **development of the seminar** will consist on analysing those alternate scenarios to anticipate associated vulnerabilities, to identify potential indicators of the plot, to evaluate their viability, to estimate consequences from them, to think on potential gaps, to support training on them, and to produce observations. Additionally, the seminar will offer a great opportunity for sharing experience, promoting best practices, and improving collaboration among agencies and security forces.
- 5. The target audience for the ATS22 are specialists from:
  - Homeland Defence/Security Departments;
  - National Security/Intelligence agencies;

- Intelligence, response, emergency management, and security matters related with Law Enforcement;

- Intelligence, response, emergency management, and security matters related with the Military;
- First response (e.g. firefight, improvised explosive device disposal...) management;
- Border control & customs;
- Emergency response and management;

- Countering terrorism;
- Critical infrastructure protection;
- Aerial, maritime, and land transportation security.
- 6. The main topics for ATS22 will be based on;
  - Alternate scenarios based on terrorist threats still not conducted;
  - Alternate scenarios based on unexpected violent actions;
  - Alternate scenarios based on actors unidentified as adversary ones;
  - Alternate scenarios based on effects over critical infrastructure;
  - Alternate scenarios based on effects over mass events;
  - Alternate scenarios based on second and third order effects;
  - Alternate scenarios based on own unidentified vulnerabilities;
  - Alternate scenarios based on traditionally unprotected events/interests.
- 7. The **design of the scenarios** will move:
  - From a basic plot to a sophisticated planning/design;
  - From terrorist groups to mobilized citizens;
  - From a mere terror induction to mass killing;
  - From requesting a unique highly specialized response to needing a fully coordinated management;
  - From a single/local incident to several coordinated actions;
  - From aiming strategic effects to looking for punctual visibility.
- 8. The event will be driven in **English language**.
- 9. Attendees will also have the opportunity to **interact and network** with colleagues from different agencies and organizations.
- 10. **Tentative agenda** with topics and administrative information are enclosed as ANNEX A & B to this letter. The final agenda will be posted on the **ATS22** section within the C-IED CoE official website at

#### 1. Registration.

## 2. Accommodation.

The organisation will provide accommodation only for selected guest briefers. Accommodation matters will fall into the own responsibility of each participant.
