- 1. In accordance with reference A and D, based on the doctrinal foundations of reference B and in order to meet the requirements of reference C, the C-IED Centre of Excellence (C-IED COE) conducts the Analyst's Notebook Users Course 22.1, from 07-11 February 2022 at the C-IED Centre of Excellence in Spain.
- 2. The aim of the ANUC is to provide attendees with the theoretical and practical knowledge about the Analyst's Notebook® software as a widely used software tool by intelligence analysts. Its intent is to train Military and Law Enforcement personnel involved in network analysis processes in their respective Units, Headquarters and Organizations.
  - 3. Representatives of the C-IED COE sponsoring nations, NATO and the "7NNN" (Non-NATO-Nations: Australia, Austria, Finland, Ireland, New Zealand, Sweden, Switzerland) are invited to attend the Analyst's Notebook Users Course which will be conducted in the C-IED COE in Madrid.
- 4. The course has in total 10 seats for attendees. The amount of seats per nation will be prioritized according to requested operational needs.
- 5. 4 seats will be granted in priority for Law Enforcement personnel. Authority for prioritization is the C-IED COE.
- 6. The <u>deadline for application</u> for the Analyst's Notebook Users Course 22.1, is **12 DEC 2021.** Applications after the deadline will not be accepted.
- 7. If nations request more than one attendant for the course, they are kindly asked to prioritize their attendees.

- 8. COVID-19 prevention measures could involve course cancelation.
- All applicants will receive the <u>confirmation/regret mail from C-IED COE not later than</u> <u>17 DEC 2021</u>. Selected participants can purchase the flight tickets after this mail. No travel arrangements should be made prior to receiving the confirmation of participation.

#### ANNEX A: COURSE DETAILS

### 1. Training Audience

a. Military and Law Enforcement from NATO, European Union primary Member States and Law Enforcement Agencies involved in network analysis processes are invited to attend the ANUC at the NATO C-IED COE facilities in Hoyo de Manzanares (Madrid, Spain).

#### b. Language proficiency

- i. An adequate understanding of written and spoken English is required.
- ii. In accordance with STANAG 6001, a level of 3.2.3.2. and the civilian equivalent, is highly recommended for students as the minimum requirement to attend and successfully fulfilled this course.

### 2. Tentative Agenda

Sunday 06 FEB: Travelling day.

Monday 07 FEB: In-processing, 08'30 h and classes till 16'45 h.

Tuesday 08 FEB - Thursday 10: 08'30 h. - 16'45 h.

Friday 11 FEB: 08'30 h. - 13`30 h. (Departure day).

The final day of the course will end promptly at 13h30. And on that Friday 11 February, **STUDENTS SHOULD NOT PLAN TO DEPART THE CoE PRIOR TO 13h30.** 

It is essential that all students comply with these timings, as personnel arriving late or leaving early will have a detrimental effect on the course and on the host nation support, as well as those students will not be provided with their Certificate of Compliance at the end of the course.
