 In accordance with references A and F, based on the doctrinal foundations of reference B and in order to meet the requirements of reference C, the C-IED Centre of Excellence (C-IED COE) conducts the DOMEX 21.2 from 16 to 27 AUGUST 2021, in Hungary.

Course Code (ETOC): IED-ED-35665.

- 2. The course aims to enhance Technical Exploitation capabilities focused in DOMEX discipline, including Document Exploitation (DOCEX), Media Exploitation (MEDEX) and Cellular Phone Exploitation (CELLEX). The framework will be initial collection capabilities and the use of elementary tools and software to extract information at the tactical level for integration into the Technical Exploitation system (level 2).
- 3. Representatives of the C-IED COE sponsoring nations, NATO and the "7NNN" (Non-NATO-Nations Australia, Austria, Finland, Ireland, New Zealand, Sweden, Switzerland) are invited to attend DOMEX 21.2 which will be conducted in the HDF NCO Academy premises in Szentendre, Hungary.
- 4. The course has in total 12 seats for attendees. 3 seats will be granted in priority for Law Enforcement personnel. Authority for prioritization is the C-IED COE.
- 5. The <u>deadline for application</u> for the DOMEX 21.2 is **23 JUNE 2021**. Applications after the deadline will not be accepted.

- 6. If nations request more than one attendant for the course, they are kindly asked to prioritize their attendees.
- 7. COVID-19 prevention measures could involve course cancelation.
- All applicants will receive the <u>confirmation/regret mail from C-IED COE not later than</u>
 <u>25 JUNE 2021</u>. Selected participants can purchase the flight tickets after this mail.
 No travel arrangements should be made prior to receiving the confirmation of participation.

ANNEX A: COURSE DETAILS

1. Training Audience

a. Fields and levels of expertise:

The course will cover the following learning objectives:

- i. Trends regarding Technical Exploitation.
- ii. Technical Exploitation Processes.
- iii. Document & Media Exploitation (DOMEX) Outcomes and their potential contribution to Attack the Networks (AtN).
- iv. Document Exploitation (DOCEX) Capabilities.
- v. Media Exploitation (MEDEX) Capabilities (including UAS).
- vi. Cellular Phone Exploitation (CELLEX) Capabilities.
- vii. DOMEX Collection Techniques in Support to Weapons Intelligence Team (WIT) processes.

Expected attendees are trained International or National WIT or equivalent trained personnel (i.e.: MP, Military Search, TEO) and Intel/Ops Staff, involved in technical exploitation.

A previous attendance to the WIT Course is recommended but not mandatory.

b. Military Ranks:

Officers (OF-1 to OF-4) and NCOs (OR-3 to OR-9) and equivalent ranks of Law Enforcement and Intelligence Agencies.

c. Language proficiency

An adequate understanding of written and spoken English is required. In accordance with STANAG 6001, a level of 2.2.2.2. is recommended for students to attend this course.

2. Tentative Agenda

The DOMEX is a two-week course. During the first week, theoretical knowledge and practical use of a number of forensics tools are provided as basis for the second practical week. The focus in the first week is the introduction to the Technical Exploitation process and capatilities, as well as a first contact with the forensics tools available during the course. The second week follows a scenario in which attendees will be required to use the acquired knowledge to exploit a number of scenes, including the chain of custody and reporting.
