1. In accordance with reference A and D, based on the doctrinal foundations of reference B and in order to meet the requirements of reference C, the C-IED Centre of Excellence (C-IED COE) conducts the ATNOC 21.2 from **18-29 OCTOBER 2021** at the C-IED Centre of Excellence in Spain.

Course Code (ETOC): IED-ED-22069

2. The aim of the course is to provide multidisciplinary knowledge and skills to integrate the comprehensive and cross-functional Attack the Networks (AtN) approach as process within the other Operational HQ processes. Emphasis will concentrate on providing AtN related situational awareness with connection to intelligence, exploitation and targeting activities in order to recommend lethal and non lethal ways to engage all networks (threat/neutral/friendly) and to assess on the engagement effects. The AtN process will be applied on operational level facing networked threats in a hybrid scenario.
3. Representatives of the C-IED COE sponsoring nations, NATO and the “7NNN” (Non-NATO-Nations Australia, Austria, Finland, Ireland, New Zealand, Sweden, Switzerland) are invited to attend the ATNOC 21.2 which will be conducted in the C-IED COE premises in Hoyo de Manzanares (Madrid).
4. The course has in total 24 seats for attendees. The amount of seats per nation will be prioritized according to requested operational needs. 6 seats will be granted in priority for law Enforcement personel. Authority for prioritization is the C-IED COE.
5. The deadline for application for the ATNOC 21.2 is **03 SEPTEMBER 2021**. Applications after the deadline will not be accepted.

6. If nations request more than one participant for the course, they are kindly asked to prioritize their attendees.
7. COVID-19 prevention measures could involve course cancelation.
8. All applicants will receive the confirmation/regret mail from C-IED COE **not later than 10 SEPTEMBER 2021**. Selected participants can purchase the flight tickets after this mail. No travel arrangements should be made prior to receiving the confirmation of participation.

ANNEX A:
COURSE DETAILS

1. Training Audience

a. Fields and levels of expertise:

NATO Intelligence, Operations, Plans, Counter Terrorism, EOD and C-IED Staff Officers and Senior Staff Assistants from upper tactical (LCC, MCC, ACC, SOCC) and operational level commands and personnel of Law Enforcement and Intelligence Agencies. The attendance of the C-IED Staff Officer Course (CSOC, also conducted in the C-IED COE), is a good preparation for the ATNOC. Especially for the participants outside of the C-IED environment (including Law Enforcement and Intelligence Agencies), the attendance of the CSOC in advance is highly recommended but not mandatory).

b. Military Ranks:

Officers (OF/2 to OF/4) and Senior NCO (OR 8 to OR 9) from across NCS, NFS, member states armed forces or equivalent ranks of Law enforcement and Intelligence Agencies.

c. Language proficiency

An adequate understanding of written and spoken English is required. In accordance with STANAG 6001, a level of 3.2.3.2. is recommended for students to attend this course.

2. Tentative Agenda

The ATNOC is a two week course. During the first week theoretical knowledge and tools are provided as basis for the second practical week. The focus in the first week is the introduction of the AtN process itself and to widen the student perspective for the broad fields of overlapping processes, disciplines and other AtN related activities on the operational level. The practical exercise follows in a fictitious scenario in which students will be required in syndicates to undertake staff functions, mainly Ops, Plans, Targeting and Intelligence, within the operational HQ going through the AtN process in order to facilitate, manage, and lead the C-IED/AtN effort.

3. Advanced Distributed Learning (ADL)

- a. The ADL is a prerequisite for the resident course. To join the resident Attack the Networks Operational Course (ATNOC), it is mandatory to successfully complete the e-learning "ADL 212 ATNOC". Students are requested to take their ADL certificate to the C-IED COE at the start at the course.
- b. This ADL will be open for ATNOC students only, having the confirmation of attending the ATNOC (confirmation letter to be sent NLT 10 SEPTEMBER 2021).
- c. Be advised, the completion of the ADL course requires a full working day.

1. Application for the course

- a. The content of given lectures will be UNCLASSIFIED but in order to keep the opportunity of discussions, notes and remarks during the course open up to a NATO SECRET level, the overall classification of the course will be "NATO SECRET RELEASABLE TO 7NNN".
- b. **The course cannot be attended without NS security clearance.**

4. CIS

- a. A briefing on the use of non C-IED COE equipment will be provided on entry.
- b. Students are not allowed to use own laptops, CD/DVD-ROMs or flash disks at Classified Areas (Class I & Class II) according to C-IED COE regulations.
- c. During the course each student will be provided a laptop.
- d. Mobile phones are not permitted inside the briefing and syndicate rooms.
